<b>Emergency Overview</b> Creamy, beige paste (liquid) with mild solvent odor. May cause headache, drowsiness or other effects to the central nervous system. May cause skin irritation.

<b>SECTION 4 - FIRST AID MEASURES</b>

<b>SECTION 7 - HANDLING AND STORAGE</b>
<b>Safe handling procedures:</b> Wear suitable protective equipment. Use with adequate ventilation. Training the workers on the potential health hazards associated with product vapor, dust or fume is important.
